I visited the 9/11 memorial in New York today and it was very moving. I first came here soon after the Twin Towers were attacked and it was very emotional then, with people walking away from the walk bridge nearby, visually upset. Today, it had an eerie feeling and reminds me of the danger all emergency responders face in their roles, whether they are Volunteers or Career staff.

I have a vision that all SES Volunteers, their families, friends and supporters, will be able to visit a place of reflection where they can remember the hard, and at times dangerous, work that SES Volunteers do in rescuing people in danger and protecting their communities from the effects of natural hazards – just like the firies now have in Kings Park.

Next year the Association will need to engage some people of influence, such as MPs and Ministers, to assist making this happen so the SES Volunteers can also be remembered for putting their lives at risk and supporting their community.

This will need to include recognition of James Regan who, in 2004, was drowned when rescuing an injured tourist in the Karijini National Park.

The Combined Legislation Concept Paper

The SESVA recently conducted an information session at the Metro Inn in Perth on the review of the legislation. There was a follow up for country Volunteers the following week.

There has been some very intense interest and it is now up to SES Volunteers to give their input on DFES preferred options and on their own preferred options

Remember this is the future of your community emergency response by SES responders and needs your input.

The SESVA will be making a submission in July based on the feedback that is being received.

The Chief Superintendents

I led a team of three (Phillip Petersen, Lin Booth and myself) to meet and go through some strategic matters with the three Operations Command Chief Superintendents - Kennedy, Cox and Johnson.

This was a non-stop four hour session which covered the roles of the SES and a number of strategic issues which are affecting the Volunteers and the effective delivery of a service to their community.

At lot of the issues are based around a lack of understanding of what the SES does and why, the outcomes of enquiries and poor communication.

The three Chiefs are to be commended for their understanding and subsequent action on a number of the issues.



The SESVA is following closely the progress and assisting the Chiefs as required.

The ESL/LGGS Manual

When the ESL came into being, over ten years ago, there was a special committee set up which included a Volunteer and staff member for each Service committee. This was abolished a number of years later and DFES then made their decisions.

It was recently been bought to the attention of the SESVA that SES Units are now restricted, dependent upon the number of registered members in the Unit, to a maximum of 3 mobiles phones, 2 pagers and 3 computers.

There has never been any consultation with the SESVA or SES Volunteers on changes to this manual. There was also no communication until earlier this year when a particular SES Unit needed its mobile phones replaced.

The SESVA has written to the DFES Commissioner requesting a hold be placed on removal of any of the excess items until a full review, in consultation with the SESVA, is completed and agreed.
