Who should apply for the National Emergency Services Training Award?

Registered member/s of a recognised Australian emergency services agencies that perform training and assessment as a part of their role. The award is open to both volunteers and career personnel.

Individuals can make applications. Alternatively direct supervisors or senior training personnel may submit an application on behalf of an individual with their consent and knowledge.

What is the criterion for the National Emergency Services Training Award?

To be considered for the National Emergency Services Training Award nominees should be able to demonstrate and provide evidence of the following:

- Increased capability and performance of individuals and/or teams as a direct result of accredited training and assessment which they have delivered
- Quality training and assessment delivery
- A professional, innovative and skilled attitude and approach to the training of emergency services personnel

How can I apply for the National Emergency Services Training Award?

Ease of applying, while at the same time ensuring adequate and sufficient evidence has been an important factor. There are two ways in which you can apply;

1. Written applications addressing the criterion identified previously and including examples, contact details, emergency services registration and experience, an outline of training experience or resume' and a signed statement of support for application from your direct supervisor and your agency's senior Training Manager. The written award application should be no more than 3 A4 pages, with the total application including supporting evidence and/or photos to be no more than 10 A4 pages
2. Video or electronic presentation format addressing the criterion identified previously and including examples, contact details, emergency services registration and experience, an outline of training experience or resume' and a verifiable statement of support for application from your direct supervisor and your agency's senior Training Manager. The video or electronic presentation application should be no more than 15 mins in length, with the total application including supporting evidence and/or photos to be no more than 30 mins in length

All applications will need to include an acknowledgement by individuals of their willingness to participate in the application, selection and recognition processes for the National Emergency Services Training Award.

When do application need to be submitted?

Applications need to be submitted no later than 18 August 2014. Finalists will be notified by 1 September 2014.
