The election results will be announced at the 2025 Annual General Meeting, 9am Saturday 13th September at the SES Volunteers Association of WA facility, 91 Leake St, BELMONT WA.

Should no nominations be received for a vacant position on the Management Committee, the Committee may co-opt a person to the relevant position.

So, to make certain your region is kept fully informed, please ensure a member is nominated if your region is one with a term ending or a vacancy.
